Lakewood Recreation offers memberships designed to help your business provide recreation benefits to employees. A company can benefit from a wellness program in many ways, including but not limited to decreases in absenteeism, injuries, worker's compensation claims, and increases in employee energy, production and morale. Lakewood Recreation offers two corporate membership plans to meet your needs:

Regular Corporate Program:

The business pays a flat fee (based upon the number of employees) and each employee and family members receives a 20 % discount off of our regular annual membership rates.

Corporate Wellness Fees (what the business pays)

Tier 1	1-10 employees	\$100 annually
Tier 2	11-100 employees	\$300 annually
Tier 3	101+ employees	\$500 annually

Corporate Wellness Annual Membership Passes (what the employee pays for an annual pass)

Adult	\$308 (regularly \$385)
Family	\$480 (regularly \$600)

Corporate Wellness Punch Card Admissions Program:

The corporate punch card admissions program allows a business to purchase admissions for its' designated employees. Admissions may be purchased and "banked" in bundles of 30 admissions, starting at a rate of \$102 per 30-admission bundle. 30-admission bundles decrease in price if multiple bundles are purchased at one time. Admissions may be used at any of Lakewood Recreation's four recreation centers, and at Lakewood Recreation's outdoor pools during the summer season.

The business will provide Lakewood Recreation a list of employees that are authorized to "draw" upon the business's pre-paid admissions "bank." These employees may visit any of the four recreation centers and identify themselves as authorized employees of the business. Lakewood Recreation staff will issue photo I.D. punch cards to the authorized employees, and the I.D. punch cards may be presented to gain facility admission. Each employee facility admission will subtract one pre-paid admission from the business's pre-paid admission bank. The business may purchase additional 30-admission bundles to deposit in its' admissions "bank" at any time.

30-admission bundle pricing:

30-admissions	\$102
60-admissions	\$195 5% Savings
90-admissions	\$289 5% Savings
120-admissions	\$367 10% Savings
150-admissions	\$434 15% Savings

Upon enrollment in either of the Corporate Wellness Plans, if any of the business's authorized employees have current individual Lakewood Recreation passes, Lakewood Recreation will arrange a pro-rated reimbursement for the current year if requested to do so.
