The Rules:

- ◆ Entries must be homemade and must contain apples.
- ◆ Bakers must bring enough samples for the pro-judging panel in addition to a minimum of 100 bite-size samples for the public judging panel.
- ◆ Bakers must present to serve their entry to the public from 10:30 a.m.-12:30 p.m., Sunday, October 8.
- ◆ Entries must include 2 copies of the recipe.
- ◆ Entries must include the completed entry form below.
- ◆ Entries must be contained on/in a disposable baking dish/plate.
(dishes will NOT be returned)
- ◆ Entries will be judged at room temperature.
(refrigeration and/or heating will NOT be available)
- ◆ Entries must be delivered between 8 a.m. and 10 a.m. on Sunday, October 8 to:
