AN ORDINANCE

AMENDING THE MUNICIPAL WARD BOUNDARIES FOR THE CITY OF LAKEWOOD,
COLORADO

WHEREAS, Ordinance O-2002-31 last established boundaries for wards and precincts in the City of Lakewood, pursuant to Section 2.7 of the Lakewood Home Rule Charter; and

WHEREAS, recent annexations of land to the City of Lakewood necessitate a change to municipal ward boundaries; and

WHEREAS, all changes to the ward boundaries of the city must be approved by the governing body.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Lakewood, Colorado, that:

SECTION 1. The City shall be divided into five wards to be numbered consecutively beginning with the number "1".

SECTION 2. The boundaries of the wards of the City of Lakewood are hereby changed so that each of the wards of the City shall consist of and contain the general election precincts listed opposite the number of each ward on Exhibit "A" attached hereto and made a part hereof by this reference; provided, however, that no portion of any county election precinct lying outside of the boundaries of the City of Lakewood shall constitute a part of any ward of the City.

SECTION 3. The City Council hereby finds and determines that the wards as provided herein are as compact and as equal in population as is practicable, taking into consideration the need to follow general election precinct lines, and the nature and characteristics of the City of Lakewood.

SECTION 4. This ordinance shall take effect thirty (30) days after final publication.
