# R-1-9

## Medium Sized Lot Residential

The R-1-9 district is intended to provide for medium-sized lot, single family residential development.

### Subdivision Standards

<b>New Lot Size</b>	Minimum:	9,000 square feet
<b>New Lot Width</b>	Minimum:	75 feet

### Building Setbacks

<b>Primary Structure</b>	Front Minimum:	25 feet
(Front setbacks are measured from back of curb. Where no curb exists, add 3 feet to setback dimensions and measure from edge of asphalt).	Non-Primary Front Minimum:	20 feet
	Side Minimum:	10 feet
	Rear Minimum:	15 feet
<b>Accessory Structure</b>	Front Minimum:	Behind front edge of primary structure
(Structures larger than 32 feet in length or with wall heights greater than 12 feet in height must meet Primary Structure Setbacks.)	Non-Primary Front Minimum:	20 feet
	Side Minimum:	5 feet
	Rear Minimum:	5 feet

### Height

<b>Primary Structure</b>	Maximum:	35 feet
<b>Accessory Structure</b>	Maximum:	20 feet

### Open Space

Minimum: 60%

### Other Standards

<b>Primary Dwelling Units Per Lot</b>	Maximum:	1
<b>Accessory Structure Lot Coverage</b>	Maximum:	No more than 50% of rear, side, and non-primary front yards and no more than 10% of total lot area
<b>Fence Standards</b>	Front:	Maximum 4 feet in height, Minimum 50% open
	Side/Rear/Non-Primary Front:	Maximum 6 feet in height, solid allowed
