A RESOLUTION

APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH URBAN DRAINAGE AND FLOOD CONTROL DISTRICT D/B/A MILE HIGH FLOOD DISTRICT REGARDING CONSTRUCTION AND MAINTENANCE OF DRAINAGE AND FLOOD CONTROL IMPROVEMENTS FOR LAKEWOOD GULCH DOWNSTREAM OF WELCH STREET

WHEREAS, pursuant to C.R.S. § 29-1-203 and § 29-1-203.5 as amended, the City of Lakewood (the "City") and Mile High Flood District (the "District") have the authority to enter into an Intergovernmental Agreement (IGA);

WHEREAS, the City will acquire interest in properties for public purposes, the City will also perform construction on Lakewood Gulch downstream of Welch Street to prevent further erosion onto neighboring properties by installing stabilizing boulder walls, drop structures, and other improvements as needed (the "Project");

WHEREAS, the District desires to assist the City with funding and constructing the Project's drainage, flood control, and channel improvements;

WHEREAS, the City and District therefore desire to enter into an IGA to fund and perform the necessary drainage, flood control, and channel improvements for the Project and to also delineate maintenance responsibilities;

WHEREAS, the total cost for the Project is anticipated to be eight hundred eighty five thousand, seven hundred and twenty-five dollars (\$885,725.00);

WHEREAS, pursuant to the IGA, the District will pay for forty and four tenths percent (40.40%) of the Project cost and the City will pay the remaining fifty-nine and six tenths percent (59.60%); and

WHEREAS, the City's 59.60% contribution of \$529,000 was previously approved by City Council in the 2024 Annual Budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lakewood:

SECTION 1. The City Council hereby authorizes a contribution of up to five hundred twenty nine thousand dollars (\$529,000.000) for the construction of drainage, flood control, and channel improvements in Lakewood Gulch downstream of Welch Street.

SECTION 2. The improvements outlined within the IGA are in the best interests of the residents of the City.

SECTION 3. The City Manager or designee is hereby authorized to execute the IGA and any other documents necessary to complete the Project.

SECTION 4. This City's Chief Financial Officer is hereby authorized and directed to pay amounts not to exceed five hundred twenty-nine thousand dollars (\$529,000.00) for the City's share of the Project cost.

SECTION 5. This Resolution shall become effective immediately upon its adoption.
