A RESOLUTION

AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AMENDED INTERGOVERNMENTAL AGREEMENT WITH THE MILE HIGH FLOOD DISTRICT AND THE CITY AND COUNTY OF DENVER FOR A MAJOR DRAINAGEWAY PLAN AND A FLOOD HAZARD AREA DELINEATION REPORT FOR SOUTH LAKEWOOD GULCH

WHEREAS, pursuant to C.R.S. § 29-1-203 and § 29-1-203.5 as amended, the City of Lakewood (the "City"), the Mile High Flood District (MHFD) and the City and County of Denver (Denver) have the authority to enter into an Intergovernmental Agreement (IGA);

WHEREAS, in 2018, the City, MHFD, and Denver entered into an IGA regarding the development of a Major Drainageway Plan and a Flood Hazard Area Delineation (FHAD) report for Lakewood Gulch (the "Project");

WHEREAS, the City, MHFD, and Denver now desire to add South Lakewood Gulch to the Project, which requires an amendment to the original IGA entered into by the parties;

WHEREAS, the proposed amended IGA includes an additional contribution by the City not to exceed one hundred thousand dollars (\$100,000.00) and an additional contribution by MHFD not to exceed two hundred fifty thousand dollars (\$250,000.00); and

WHEREAS, the City's anticipated contribution of funds were included in the Lakewood 2024 approved budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lakewood, Colorado, that:

SECTION 1. The City Council hereby finds and determines that authorizing the City Manager to enter into an IGA, attached hereto as Attachment A and incorporated herein, between the City, MHFD, and the Denver regarding the development of a Major Drainageway Plan and a Flood Hazard Area Delineation report for South Lakewood Gulch is and shall be in the best interest of the residents of the City, and hereby authorizes the City Manager to enter into the IGA with MHFD and Denver on behalf of the City.

SECTION 2. The City Treasurer is hereby authorized to make payment to the Mile High Flood District in accordance with the terms of said IGA.

SECTION 3. This resolution shall become effective immediately upon its adoption.
